Thank you for your interest in our Club. It was formed in 1988, exactly 24 years after the first Austin 1800 was unveiled to the public. The Club caters for the Mk.I.; Mk.II and Mk.III Austin, Morris and Wolseley variants produced by BMC and BL between 1964 and 1975.

The first problem the Club faced was a suitable name; originally called the 'Austin-Morris 1800/2200 Owners' Club', this was considered too much of a mouthful, nor did it mention the Wolseley. Very few people know of the official factory coding of 'ADO17' (ADO = Austin Drawing Office) so that seemed inappropriate as well.

The Landcrab name comes from the 1960s when the cars were used a lot in International Rallies. A motoring journalist remarked that as the cars cornered sideways they looked just like 'Landcrabs'. The name has been used as a term of affection for these cars ever since. And so the name of the Club came about.

We offer the owner/enthusiast a friendly and informal service. Through the Club magazine 'Landcrab News' we hope to offer technical tips, articles on the cars' history, news of events, etc.

One of the Club aims is to locate sources of spares to keep all examples of these cars on the road — to this end we operate a comprehensive and efficient spare parts service.

The Club exhibits cars at shows up and down the country and organises its own events and social calendar. There are several local groups meeting around the UK.

The Club has a truly international membership with members as far afield as Australasia, North America, South Africa and most of Europe. This widespread membership reflects the growing interest in these popular cars.

CONSTITUTION

1. INTRODUCTION:

- The name of the Club is: "Landcrab Owners' Club International Ltd Company Registration Number 040 15592" hereafter referred to as the Club.
- All members shall abide by the Constitution and any amendments made to it.

2. THE OBJECTIVES OF THE CLUB SHALL BE:

- The preservation of the vehicles manufactured by the British Motor Corporation and its successor British Leyland as defined by the Committee of the Club.
- To cultivate an interest in the 1800/2200 by providing technical advice, general literature and where possible, sources of spare parts for maintenance and restoration.
- To maintain a record of all vehicles owned by members.
- To publish a regular Magazine/Newsletter.
- To liaise with other clubs and societies with similar aims and objectives.

3. MEMBERSHIP:

Membership is open on condition of:

- Ownership of, or interest in, any vehicle as defined by the Committee of the Club.
- Payment of such subscriptions that are stipulated from time to time by the Committee of the Club.

The following options are offered for membership:

- STANDARD — an annual subscription, renewable each April.
- LIFE — a single, non-refundable subscription, without the need for subsequent renewal, to be paid on joining or renewal, equivalent to TEN times the STANDARD rate applicable at the time of payment.

- HONORARY MEMBERSHIP shall be given to any deserving persons, for such period as the Committee of the Club decides, without payment of any kind. Honorary members shall not be eligible to vote at Annual General or any other Extra-Ordinary meetings or hold any official positions.

NOTE: The Committee reserves the right to refuse membership to any person that they feel has not or will not serve the aims and/or objectives of the Club.

EXPULSION: The Committee reserve the right to ask any member to resign their membership if in their opinion it is in the interest of the Club to do so. Persons refusing to resign shall have their membership suspended until such time as they can appeal to the next Annual General Meeting or an Extra-Ordinary meeting. Any such person shall not receive a refund of their subscription.

4. GENERAL ADMINISTRATION:

The Committee of the Club are the ONLY persons authorised to make any public statement or announcement in the name of the Club.

- The name and address of the Club shall not be used by any member for use in any Trade or Business or advertising, except as may be necessary for the Club's sponsorship or promotion at the discretion of the Committee, or in conjunction with any legal proceedings.
- Each member shall be provided with this Constitution and any amendments thereto, a copy of the magazine/newsletter and any other publication which may be issued by the Club from time to time, upon payment of the prescribed subscriptions.
- There shall be an Annual General Meeting of the Club, its members and Committee at a time and place that may be fixed by the Committee as circumstances decide.
- Every member shall be issued with a membership number and, having paid their subscription for that year, shall be entitled to ONE vote at the Annual General Meeting.
- Co-opting: The Committee may co-opt members onto the Committee as circumstances dictate; any such appointments must be confirmed at the next Annual General Meeting.

- Should any member require a matter to be discussed by the Club, including alterations to this Constitution, a written request must be submitted to the Secretary, countersigned by two fully paid-up members, at least one month before the Annual General Meeting to enable it to form part of the Agenda. If more than 10% of the membership sign such a request then an Extraordinary meeting may be called.

5. DUTIES OF THE SECRETARY:

The secretary is responsible for the general administration of the Club and will co-ordinate the organisation of all Club activities.

6. DUTIES OF THE TREASURER:

The Treasurer shall keep proper accounts which are to be prepared and presented, observing the normal procedures for same, in the form of a Statement of Accounts.

7. FINANCES:

- All monies paid to the Club are to be held in a suitable account(s) in the name of "LANDCRAB OWNERS' CLUB INTERNATIONAL LTD".
- All transactions should be by Cheque, Postal Order or by Standing Order.

8. USE OF NAMES AND ADDRESSES:

- The list of members' names and addresses will not be released to any outside organisation.
- The Club Directory is issued only to members who are current at its time of release; members who wish to remain 'ex-directory' either in part or in full should inform the Membership Secretary so that their details may be withheld.
- Individual names and addresses will only be released with the prior approval of the member concerned.

9. DISSOLUTION OF THE CLUB:

The decision to dissolve the Club can only be made by a General Meeting convened expressly for that purpose. If the dissolution is approved, the Committee shall forthwith hold a postal ballot of all paid up Club Members. If the vote in favour totals more than 75% of the votes cast, the Committee shall forthwith liquidate the Club's affairs. Any surplus monies at the end of the liquidation will be donated to a chosen charity.
